PROPOSED ORDER

GOOD CAUSE HAVING BEEN SHOWN, it is hereby ordered as follows:

The Court, having considered Plaintiffs' Motion for an Order to appoint and QSF Trustee for purposes of effectuating the global settlement, and any oral argument presented at the hearing before the Honorable Lawrence P. Riff on December 4, 2025, at 8:30 a.m., in Department 1, and for good cause appearing, hereby finds and orders as follows:

1. Subject to satisfaction of certain conditions, the County has agreed to pay up to \$828,000,000.00 ("Settlement Amount") to a qualified settlement fund for distribution to all plaintiffs participating in the master settlement agreement to resolve claims in this action. The parties have agreed to engage and to seek Court appointment of Simpluris as QSF Trustee to effectuate the terms of the settlement.
2. Simpluris is hereby appointed by the Court as the QSF Trustee and will be the trustee for the qualified settlement fund into which the County has agreed to transfer the Settlement Amount (subject to satisfaction or waiver of the conditions precedent). The QSF Trustee shall have authority to conduct any and all activities necessary to administer the QSF and shall administer the funds in the QSF under the terms of this Order and its engagement.
3. The Qualified Settlement Fund is established as a qualified settlement fund by Order of this Court. The QSF is the fund into which the County will pay the Settlement Amount, and the QSF shall remain subject to the continuing jurisdiction of this Court until its purposes have been accomplished and the QSF is dissolved. The QSF's purpose is to fully resolve Settling Plaintiffs' tort claims arising from alleged past acts of sexual abuse, and it meets the criteria for a "qualified settlement fund" under 26 C.F.R. § 1.468B-1 and for a "designated settlement fund" under 26 U.S.C. § 468B.
4. The QSF Trustee is authorized, upon final distribution of all monies paid into the QSF and allocated to Plaintiffs, to take appropriate steps to wind down the QSF, and thereafter shall be discharged from any further responsibility with respect to the QSF.
5. Pursuant to Code of Civil Procedure section 664.6, this Court retains continuing and exclusive jurisdiction to enforce and resolve any dispute regarding the Global Settlement and the terms in this Order until their performance in full. No motion,

1 claim, suit, action, or proceeding of any kind relating to the foregoing may be brought
2 or filed in any other court and any party doing so will be in violation of this Order
3 and subject to an order to show cause as to why the party should not be held in
4 contempt.
